What is Forensic Odontology?



Forensic Odontology Question/Answer

1) Is forensic odontology only for identifying victims of murder? No, forensic odontology is used to identify victims from multiple other instances. The dental records can be used to identify people from disasters, fires, if there is no other way of identification, or even identifying a person who left behind a bite mark.

Limitations Questions/Answers

1) Are there any universally accepted protocols for Forensic Odontology? - No, opinions are completely up to the individual odontologist

2) Can a person's dental profile change? If possible, in what ways? Yes, it can change. It changes if someone loses teeth, tooth rot, or even dental procedures (braces).

3) Are bite marks on the skin going to stay the same throughout time? No, skin will heal and change over time. Decaying flesh will distort the impression.

4) What type of skin has been used to study how effective forensic odontology? What limitations has that shown? Pig skin has been studied but it doesn't have the same elasticity as humans. It hasn't been completely reliable information.
