How did you do?- *Due process, a course of legal proceedings according to rules and principles that have been established in a system of jurisprudence for the enforcement and protection of private rights. In each case, due process contemplates an exercise of the powers of government as the law permits and sanctions, under recognized safeguards for the protection of individual rights.*

What is Due Process?

Clause included in the Fifth and Fourteenth Amendments to the United States Constitution ensuring that no person is deprived of his life, liberty, or property without due process of law.

14th Amendment=

all persons deserve due process- not just white men

Examples:

- The right to an unbiased trial
- The right to be given notice of the proposed trial and the reason for it
- The right of the individual to be aware of evidence against him
- The right to cross-examine witnesses for the opposition
- The right to present evidence and call witnesses
- The right to be represented by counsel

4 due process

When the police set up roadblocks, they're supposed to create a randomized rule (example: every fourth car) and not stop anyone based on race or gender.



The process all people are guaranteed when accused of a crime. All of the procedures must be followed or it is a violation of your constitutional right to due process of law

PRINCIPLES OF THE CONSTITUTION

POPULAR SOVEREIGNTY

The people establish government and are the source of its power.

LIMITED GOVERNMENT

Government powers are restricted to protect individual rights.

SEPARATION OF POWERS

The power to govern is divided among executive, legislative, and judicial branches to prevent the concentration and abuse of power by any one branch.

CHECKS AND BALANCES

Each branch of government has the authority to check, or restrain, some powers of the other two branches.

JUDICIAL REVIEW

The judiciary has the power to strike down laws and other government actions as invalid under the Constitution.

FEDERALISM

The rights of the states are protected by dividing powers between the national government and the state governments.
