SKIP - A - PAY

Just in time for the holidays! Skip-A-Pay offers you the flexibility to pick when you want to skip! Pick the month you want to skip your loan payment, **October, November or December**, for a small fee of **\$25.00** per loan.

**Some restrictions apply, call the credit union to see if you qualify. Skip a Pay is only allowed 2 times per loan term and once annually. You must have made a minimum of 6 months of payments to qualify.

Attention to all those participating in our Christmas Club program, all funds in the Christmas Club accounts will be deposited in to your share savings. Please contact the credit union when you are ready for your funds as we will be happy to send you a check or direct deposit your funds into your checking account for those with pre authorization on file.

New Christmas Club starts October 1, 2024, with these parameters: *The account cycle is October 1, 2024 to September 30, 2025

*Periodic payments must be made during the cycle
*If funds are withdrawn before the end of the cycle the
dividends are forfeited and the club account is closed until
the new cycle begins.

Dividends Declared
