## 7 & 8 Grade Medical Detectives Lesson: Forensic Anthropologists, May 18, 2020

## Objective/Learning Target: Lesson 31, Part 1

## Students will learn how forensic anthropologists are an important part of the CSI investigative team.

#### Lesson Introduction/Background Information:

<u>Forensic Anthropologist:</u> The primary task of a forensic anthropologist is to gather and interpret evidence to assist in the identification of human remains and determine the cause of death. Their study of human remains aids in the detection of a crime by working to assess the age, sex, stature, ancestry and unique features of a skeleton, which may include documenting trauma to the skeleton and its postmortem interval. Therefore, forensic anthropology is considered a criminal justice career.

Click on the link to the right, which will take you to the website, Becoming a Forensic Anthropologist. Read over the information about becoming a Forensic Anthropologist, scroll, down to the last video on the page that looks like the link to the right and let's watch <u>Meet the Smithsonian's Bone Detectives</u>.



## Practice:

We're going to learn more about how forensic anthropologist learn from the bones they find, and examine, and are actual CSI Investigators. Once again, click on the link, to the right, which will take you to the same web page and scroll to the first video,

Bone Biographies of Early Americans. Watch the video to see exactly what they do, how they can investigate history and find a plethora of information.
